

# Postal Voting Form

In accordance with the Swedish act (2020:198) on temporary exceptions to facilitate the conduct of general meetings for companies and associations, the Board of Directors of Balco Group AB (publ) (company reg.no. 556821-2319) (the "**Company**") has decided that shareholders of the Company shall be able to exercise their voting rights at the annual general meeting (the "**AGM**") only by postal voting.

If shareholders wish to exercise their voting rights, the completed postal voting form and any enclosed authorization documents must be received by the Company no later than on 24 May 2021.

## Instructions for postal voting

1. Complete the details of the shareholder above.
2. Mark the boxes below to indicate how the shareholder wishes to vote.
3. Print out and sign the form (where it says "Signature and the signatory's name in capital letters" above). Send the original form to Computershare AB, "Balco Group Årsstämma", Box 5267, SE-102 46 Stockholm, or via e-mail to [info@computershare.se](mailto:info@computershare.se). Shareholders may also submit the postal vote electronically by verification with BankID in accordance with the instructions on the Company's website [www.balcogroup.se](http://www.balcogroup.se).

Please note that shareholders who have their shares nominee registered must register the shares in their own name in order to vote at the AGM. Instructions for this can be found in the notice of the AGM.

If the shareholder is a legal entity, a certificate of registration or other equivalent authorization document must be enclosed with the form. The same applies if the shareholder votes by post through a proxy.

For information on how personal data is processed in connection with the annual general meeting, please refer to the notice of the AGM.

### Further information regarding postal voting

The shareholder cannot give any instructions other than by marking one of the boxes for each item listed below in this form. If the shareholder has provided the form with special instructions or conditions, or changed or made additions to the printed text, the vote will be regarded as invalid.

Only one form per shareholder will be taken into consideration. If more than one form is received by the Company, only the most recently dated form will be taken into consideration. If two or more forms have the same date, only the form that is most recently received by the Company will be taken into consideration. Incomplete or incorrectly completed forms may be disregarded.

Complete postal voting form, including any enclosed authorization documents, must be received by the Company no later than on 24 May 2021. Postal votes can be withdrawn up to and including 24 May 2021, in the same manner as when submitting the vote.
